MINUTES

CALL TO ORDER: Chair Jon Doemel called the meeting to order at 10:00 a.m.

CHAIR'S REMARKS: Chair Doemel thanked members for participating in the meeting and shared his appreciation in their commitment. Chairman Doemel shared his hope that this committee will come out with some guidance for counties soon to help counties in their decision making.

DISCUSSION ITEMS:

- a. **Meta House Presentation:** Sarah Koehn and Caty McDermott spoke about the Meta House organization. This foundation was created to be a place where women who struggle with substance abuse and recovery to serve as a place where they can get services and bring their children as well. Sarah provided an overview of their organization and how they want to partner with counties to expand their services throughout the state of Wisconsin. Meta House is currently in 40 counties and hoping to continue expansion. The organization would like counties to be aware of the services they provide and be an option for investment in partnerships. The committee will connect again in the new year and discuss the next steps for their report.
- b. **PSW Toolkit Update:** Danielle spoke to the task force about the steps that they have made in the toolkit that will be used as a guidance for pharmacies across the

state to partner and connect with local governments on how they can work together to combat the opioid epidemic.

- c. Planning for Third Opioid Summit: The group discussed the topics and general format of the third opioid abatement summit that is scheduled for January 12, 2023. The group shared ideas such as including a panel of overdose fatality review teams, regionalized group discussion, and post treatment services.
